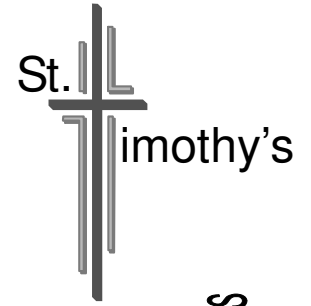

Council/Call Committee Message

How blessed St. Tim's was to have Pastor Stoa be our Interim Pastor during the last ten months. It was nice to see so many people turn out for his last worship service and going away celebration on January 8th. Saying good-bye was a little easier because we know we will see him again when we need pulpit supply.

The Church Council is asking the Congregation for their continued support as we enter this time of transition between Pastor Stoa and a new Pastor. We ask you to continue worshiping faithfully and to keep this Congregation, Council and Call Committee in your daily prayers. We will continue to work faithfully in the matters of this church.

At the time of this writing, the Call Committee is moving toward the final selection process for calling a Pastor, which takes some time. Once the Call Committee has decided on a final candidate, they will then make a recommendation to Council. Then the Council and Call Committee will meet together with the candidate. After this meeting has been held, Council needs to make a recommendation that the Congregation approve this candidate. Once the recommendation is made, it will require a vote by the Congregation. A special Congregational meeting will be announced. Our constitution requires a 15 day written notice be given to the Congregation before such a meeting can be held. The notice will be sent out by first class mail. Once the Congregational vote has been taken, and the call is accepted by the candidate, the candidate must then give a 30 day notice of separation to their current congregation.
